

# What is the Police & Community Relations Council and who are our members?

We are a voluntary, independent and self-constituted body of private citizens responsible to our members and the council. We are all residents of or work within the area of Precinct 8. Some of us are individuals, others are leaders of community groups and some represent local businesses.

#### What is the PCRC Mission Statement?

To help make Baltimore County a better place to live through the mutual understanding of the respective problems and concerns of the Baltimore County Police Department and the citizens of Baltimore County, the role of law enforcement agencies and the responsibility of the entire community for law enforcement.

To develop through the involvement of community leaders, clergy, business owners and executives, parents, police officers, social workers, educators, and others, a county wide consciousness of the need for mutual cooperation and commitments in the improvement of, and respect for, the maintenance of law and order.
